# Chairperson's report – Steve Warren

### AOB

- DM noted that our rules state that when running on road, people should be in single file. It was agreed to remove this. It was also agreed to remove the requirement for runners to wear light or fluorescent coloured clothing during daylight. During evening/dark night runs, runners should be in fluorescent and reflective clothing and wearing a head/body torch or carry a torch where appropriate. It was agreed that run leaders should try to encourage runners to do this.
- GS it was agreed that GS would continue to post on the non-members page about things that the group has been doing.
- PM in previous years we have paid £250 to the Yeovilton Sports Fund. It was agreed to continue with this.

- TW has confirmed that he has spoken to people regarding sponsorship for the 5k series. RNAS members will be offered a discount for taking part in the 5k series.
- Town Tree Trail AH and SW have met with them; it will go ahead on the proviso that it would be open up for members of the public. It was also agreed that members of YTRRC would be able to visit for free. Ah confirmed that over the last two years we have raised over £3000. Some has been given to the pre-school however there is enough money left in the account that we would be able to pay for the bridge repairs and other items. Date for race is May 21<sup>st</sup> 2025. Primary Schools cross country is now on 10<sup>th</sup> February but not sure about venue. Showground is out of use until after March. The following one on 3<sup>rd</sup> March will be at Aldon Hill.
